

B4SA: Weekly Update 07 May 2021

Dear B4SA and healthcare colleagues,

You will undoubtedly have followed developments over the past few days related to the South African COVID-19 vaccine acquisition and rollout programme. Colleagues will be aware that we established the B4SA vaccine platform to provide up-to-date information on bilateral and multilateral engagements with government, hopefully enabling businesses to respond to the latest news.

The coronavirus is not going to simply disappear. We are at a critical juncture, one that may mean the difference between being badly impacted by a third wave or not. We need to be proactive – and get vaccinated. The government's Electronic Vaccination Data System (EVDS) has been live since mid-April, and yet only 11% of those over 60 have registered. We need to make a concerted effort to ensure that more people register.

The rollout of Phase 2 on 17 May is greatly anticipated, but not without some trepidation, given the challenges we have faced, including a delay due to the possible contamination of some vaccines – fortunately not those in South Africa – and unresolved policy issues.

To make Phase 2 a success, those eligible – over 60 – must register on the government's Electronic Vaccination Data System (EVDS). Please use your businesses and corporate mailing lists, use community and sporting groups, and encourage others to step up the campaign to get over-60s to register. The science behind this is solid. What we need now is an even greater effort to push the registration numbers up.

We are determined that the rollout gets underway without further delay – the vaccines are available, and the vaccination sites are in place. The size and scale of the rollout will be massive, and we need to be prepared. B4SA has assured the government that we shall do everything possible to facilitate and support its efforts.

Stay safe – register if you are over 60, and tell and help others to do the same.

The impact


As of 6 May, the cumulative number of COVID-19 cases identified in South Africa is 1 590 370.

Bringing the entertainment and sporting federations on board

We have had positive engagements with the CEO of Big Concerts, who is kindly extending our appeal for more voices to encourage registrations to all of the sporting federations, in the hope that individual athletes and artists will spread the word.

Phase 2: The national vaccination programme starts with the over-60s

Data shows that the elderly have the highest risk of hospitalisation and mortality, which is why the vaccination programme is targeting the elderly to get them vaccinated by winter. This is the single most important positive action_by South Africa in our 14-month fight against Covid-19.



We have secured sufficient doses to vaccinate the entire eligible population and we are setting up thousands of public and privately operated vaccination sites across the country. This is the start of a massive national effort to accelerate the vaccination programme that will save lives, reduce hospitalisations, and set us on a path to rebuild livelihoods and restore the economy. To succeed, we need the support of business, government, social partners and citizens.

On **Friday, 7 May,** Business for South Africa (B4SA) and the Government Communication and Information System (GCIS) briefed the business community on the current status of Phase 2 of the vaccination programme and outlined critical practical aspects related to the rollout.

NdoH definition of Healthcare Worker beneficiaries for Phase 1B vaccinations



Vaccinating all healthcare workers remains a national priority. As part of the Phase 1 rollout, registration is now open for all Phase 1B beneficiaries, including all OUT OF HOSPITAL (OOH) healthcare worker staff. It is vital you register and schedule yourself, and your employees, for vaccination as a matter of urgency.

The steps to follow for registration are below.

Steps to vaccination registration in Phase 1B: — *Note: this is specifically for private sector HCWs.*

Step 1: Register on the EVDS system: <u>https://vaccine.enroll.health.gov.za</u>

Step 2: Health care providers register all staff on V4HCW portal: <u>http://staff.v4hcw.co.za</u>

Step 3: Health care worker self-registration. <u>http://register.v4hcw.co.za</u>
